judgement. Haas hopes to get the \$8,000.00 owed. He plans to file a motion to the courts to ask Judge Favre to have the homeowner pay all money owed.

- Haas also spoke with HCUA Director David Pitalo concerning Bay St Louis buying water. Chairman
 Lamy stated there is going to be a workshop to discuss this problem. According to the Bay St. louis
 City Council there is no one complaining about the water. It is also possible that PWSD water cost
 could increase up to \$1.50 per thousand if BSL doesn't participate. Chairman Lamy stated he will
 learn more at workshop.
- Motion was made by Vice Chairman Bell, seconded by Commissioner Bennett to have Attorney
 Haas send a letter to the Hancock County Board of Supervisors for reappoint of Rosa Jackson to
 the PWSD Board. (Attachment 8B). Motion Passed 100%. With Rosa Jackson abstaining.
- Motion was made by Commissioner Jackson, seconded by Vice Chairman Bell to have Attorney
 Haas send a letter to the Hancock County Board of Supervisors for reappoint of James Bennett to
 the PWSD Board. (Attachment 8C). Motion Passed 100%. With James Bennett abstaining.
- Motion was made by Commissioner Pavlovich, seconded by Vice Chairman Bell to have Attorney
 Haas request reappointments to keep record of future appointments and reappointments. Motion
 Passed 100%.
