March 15, 2017

GUEST PRESENTATION

Bill Cork, CEO of the Port and Harbor Commission, presented to the Board a packet of information (*Attachment 2.A*) regarding the projected water and sewer needs of Port Bienville. He discussed possible collaboration with the Pearlington Water and Sewer District to enable the Port to obtain Project Ready Certification.

Ty Necaise presented an additional packet of information (*Attachment 2.B*) outlining the steps to be taken by the PWSD to facilitate a possible connection to Port Bienville which would enable PWSD to obtain a second water source and thereby improve its rating, as well as facilitate economic growth in the county.

Chairman Report

 HCUA – The HCUA expressed disapproval of PWSD's attempt to collaborate with Port Bienville regarding water connection for the purpose of improving the district's rating. Hancock County Water and Sewer District has the certificate for the area encompassing Port Bienville, and HCUA feels Hancock County Water and Sewer District should be in discussion with the Port. PWSD will continue to study possibilities for a second water source to improve District rating.

CPA REPORT (TY NECAISE)

- Budget Amendment Motion was made by Commissioner Jackson, seconded by Commissioner Wilkinson, to approve the Budget Amendment as presented by Mr. Necaise. (*Attachment 6.B*) Motion Passed.
- **Budget vs Actual Report** Mr. Necaise reviewed the Profit and Loss Budget vs the Actual Budget. (*Attachment 6.A*)

GENERAL MANAGER REPORT

Operations:

- **Unaccountable water loss** The water loss remained at 30%. The office will be researching raw data to see if the numbers are adding up.
- **Credit Card Use** The charge for credit card use by customers has been lowered to \$3.25, per agreement with the service provider.
- Misplaced step tank To correct an original step tank installment on a neighbor's property, attempts are being made to find a tank system that will fit in the space available on the owner's property. Request for reimbursement will be placed on the agenda for HCUA since they were responsible for the original installation on the wrong property.

ENGINEER REPORT

A Hydraulic Analysis was recommended by Scott Burge. The report would show benefits of the Pearlington system and the Port system and how the connection will be beneficial to both. The proposed cost of the report exceeded the amount budgeted for the report. **Motion** was made by Commissioner Jackson, seconded by Commissioner Wilkinson, to rescind the budget amendment as presented previously in this meeting. **Motion passed**. Discussion. **Motion** was made by Commissioner Jackson, seconded by Commissioner Wilkinson to approve the second revised budget amendment to
