**Agenda** – **Motion** was made by Commissioner Jackson, seconded by Commissioner Bell, to accept the agenda as presented. **Motion passed**.

### **REQUEST TO SPEAK (Guest Presentation)**

• Letter from customer account 89 regarding balance. We have a situation that had a judgement on the property years ago. The son lives in the house, and never hooked up to the water. Used the well on property. Sewer was in use but never paid bill. Disconnected sewer and customer hooked water up illegally. No adjustment can be made to the account. Offer customer a payment plan not to exceed 12 months.

- **Motion** was made by Commissioner Bell, seconded by Commissioner Jackson, to accept the March 2018 Docket of Claims. (*Attachment 4B*) **Motion passed**.
- **Motion** was made by Commissioner Bennett, seconded by Commissioner Jackson, to accept the February 2018 Treasurer's Report. (Attachment 4.C) **Motion passed.**
- Motion was made by Commissioner Jackson, seconded by Commissioner Bennett, to authorize Commissioner Pavlovich to attend board member training. (attachment 4D) Motion passed.
- **Motion** was made by Commissioner Jackson, seconded by Commissioner Bennett, to authorize account 741 for a leak adjustment in the amount of \$1,362.52. **Motion passed**.
- **Motion** was made by Commissioner Jackson, seconded by Commissioner Bell, to authorize account 96 for a leak adjustment in the amount of \$76.70. **Motion passed**.
- **Motion** was made by Commissioner Jackson, seconded by Commissioner Bell, to authorize account 506 for a leak adjustment in the amount of \$132.90. **Motion passed**.
- **Motion** was made by Commissioner Jackson, seconded by Commissioner Bennett, to authorize account 61 for a leak adjustment in the amount of \$100.30. **Motion passed**.
- **Motion** was made by Commissioner Jackson, seconded by Commissioner Bell, to authorize account 8201 for a leak adjustment in the amount of \$303.45. **Motion passed**.

#### **OPERATOR'S REPORT**

- When account 742 was installed by HCUA the water was never hooked up, but the S-tank was
  installed. The customer is now asking who is responsible to hook up water from the meter to
  house. The Board advised the Operator that the customer has to pay to install the water line to
  the house.
- Account 602 Results: Meter was tested and was found without defects. Ms. Bowers
  recommended we explore a new policy that authorizes us to charge customers for out-of-pocket
  costs due to their negligence. We will give the customer ample warning. The Board suggested
  the staff draft a policy to be Board approved.
- Increased cost due to customer negligence: The Board discussed having panels where customer
  could not turn alarms off. Results: If the customer fails to contact us they could get charged for
  damages incurred by the District. Ms. Bowers will determine if we can relocate the alarm switch
  and prevent customers from turning the switch off.

#### **ENGINEER REPORT**

 Oak Harbor Update- Mr. Burge gave an update on his progress and recommended the Board decide how it would like to proceed. Mr. Necaise is in discussions with a grant person. USDA will give us funding that will be 45% grant and 55% loan, but we would like at least 75% grant funds. If we pursue this action it will take several months, and maybe up to a year, to finalize the funding. No action was taken at this time.

#### **CPA REPORT**

• Mr. Necaise presented the year-to-date budget. The district's financials are better than projected and are currently showing a surplus. No action was taken.
