# **OPERATOR'S REPORT**

**Operator Zoe** stated no new installs in the past 30 days. RV Park Owner has gotten the electrical panel installed and inspected, ready to go. RV Park Owner is now installing pipes for water and sewer hookup. Operator Zoe stated PWSD received 40 new meter heads from RG3 and they have been installed. Awaiting 40 more meter heads and will install when they arrive. Due to Covid 19 there has been a delay in getting the meters. CPA Necaise stated that the office personnel is still averaging or using the minimum rate on bills with new installed meters, so the district does not overcharge resident. This was because the meters did not have a full month of reading for the June-July billing cycle. PWSD will lose about \$50.00 for faulty meters.

#### **ENGINEER REPORT**

Engineer Burge Stated still does not know when the Go Mesa funding will be granted. It had to go to the Legislature so not sure when it will be decided. Oak Harbor did make the list.

Legislature is now deciding whether to do 1<sup>st</sup> and 2<sup>nd</sup> phase. 1<sup>st</sup> phase on half the projects now or do both phases in January 2021. CPA Necaise asked if the Oak Harbor Project is not funded in either phase what is the next step for PWSD. Engineer Burge stated PWSD should proceed with the purchase of the Oak Harbor System. Engineer Burge stated he is hoping the Oak Harbor project is in the 1<sup>st</sup> round and we may hear something in the next 2 weeks. CPA Necaise asked if all paperwork is complete for the Oak Harbor Project. Engineer Burge stated yes and if Oak Harbor is not funded during these rounds we will have to resubmit in July 2021.

# **CPA REPORT**

**CPA Necaise** stated PWSD budget looks great and if we continue where are PWSD should break even. Due to a slightly higher insurance cost we need to tweet the budget for next year. Chairman Lamy asked if there is money in the budget for employee raises and outside services. CPA Necaise stated no, and we would have to increase the budget for raises. Chairman Lamy stated he would like to keep funding in the budget for possible takeover of the PWSD lift station. CPA Necaise stated we need a budget workshop. Chairman Lamy may be out of town so we will need to get a date that will work for everyone. CPA Necaise stated he will come up with a date and will contact each board member to see if it will work for them. The Board is unable to have a Tele-Conference workshop due to budget spreadsheets.
