# PEARLINGTON WATER & SEWER DISTRICT BOARD OF COMMISSIONERS REGULAR MEETING MINUTES

#### October 2020

The Board of Commissioners of the Pearlington Water and Sewer District met in official session on Wednesday October 21, 2020 in the Pearlington Recovery Center.

Chairman Lamy called the official meeting to order at 5:00 p.m. Pledge of Allegiance was said, followed by a moment of silent.

## **REQUEST TO SPEAK (Guest Presentation)**

Jeremy Lee paid a deposit and connection fees of \$200 in 2017. At the time he qualified for a grant to have his step system installed with no charge however the policy period and grant ended in 2019. He was informed by District employees that he must pay \$2,400.00 to complete the water & sewer installation. PWSD has no programs in place to assist customers who cannot pay up front costs. PWSD decided that Mr. Lee could make payments being that he was not given the full cost at the time of the application. Mr. Lee was advised the office will be in contact with him.

**Motion** was made by Commissioner Jackson, seconded by Commissioner Pavlovich that PWSD will allow a one (1) time only payment arrangement due to misinformation given at the time of the application. Mr. Lee must pay \$500.00 down and monthly installments of \$140.00 along with his regular monthly water and sewer bill; this amount will be paid off in 14 months. This is not a policy change. **Motion Passed 100%.** 

Mark Allen with White's Bayou RV Park presented questions about his bill. CPA Necaise explained how bill was calculated helping him understand he was not overcharged. Mark Allen also asked when he will be billed \$3,800.00 for his new install. We advised Mr. Allen he needs to come and pay this amount right away. This amount is usually required before install. Mr. Allen stated he was not aware of the amount

schedule when customer apply for service and installations.

payment plan, but the balance must be paid in full.

Commissioner Jackson requested that Haas get updated information on the ownership of the 7<sup>th</sup> Avenue property we received a judgement on. The residence currently has no water and sewer service, but the property appears to be occupied.
