- **Dallas Trammell** The customer expressed concern about excessive use of water reported on her water bill on certain dates. The PWSD Operator offered to change the meter head and watch it for 2 months. The initial reading information will be left on a doorhanger.
- Tanya McArthur The customer lost her residence to the state for taxes. Money was owed PWSD when the state obtained the property. The customer has regained the property and is requesting information about possible options to pay previous sewer and water bill. She was informed that she would need to pay the reconnect fee and 50% of the previous bill. At that time, she would be eligible for a payment plan to pay the remaining amount. The customer agreed to provide documentation of the dates she was not in possession of the property.
