Election of Officers:

Concern was expressed that the current PWSD Board of Commissioners' meeting time of 4:00 p. m. was creating conflict with work schedules of some of the commissioners. There was also concern that the meetings were being held at a time that prevented attendance by customers of the entity. **Motion** was made by Commissioner Jackson, seconded by Commissioner Bell to change the meeting time of the regular PWSD Board of Commissioners' meetings to 5:00 p.m., effective February 1, 2016, and to post necessary notification of same. **Motion passed**.

- HCUA Activity
 No new activity has occurred to resolve the major funding issues of HCUA.
- Motion was made by Commissioner Jackson, seconded by Commissioner Bell to pay HCUA the money owed for Over/Under Billing in the amount of \$953.00. Motion Passed.

BOARD MEMBER REPORTS

CPA'S REPORT (TY NECAISE)

 Delinquent Balance: The inactive delinquent balance doubled from September of 2014 to September of 2015 because the previous system of billing was ineffective. With a better system in place, the accounting has improved. However, some of the customers with outstanding balances have moved away and others are now deceased. The PWSD is seeking the assistance of the Health

Department to achieve ordinance compliance. Lawsuits are pending for three high-balance customers.

- Board Per Diem: The allowable per diem for commissioners is \$84 per meeting. Other entities in the
 county are providing their commissioners \$84 for each meeting. The PWSD commissioners are
 donating a great amount of time in attending related meetings, answering phone calls, etc. Motion
 was made by Commissioner Jackson, seconded by Commissioner Bell, to increase commissioners'
 per diem as allowed by statute to \$84, effective February 1, 2016. Motion passed.
- Website: The PWSD website is up and running. Ty Necaise demonstrated use of the site. The site is
 mobile friendly, allowing customers to access the site by phone. Customers may pay bills through
 the site. The utility bill will advertise the website, notification will be posted in the office, and a press
 release will appear in the Sea Coast Echo.

The PWSD General Manager reported that a previous customer complaint of sewer odor in the customer's neighborhood had been resolved.
